The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Assistant Director of Care, several Registered Nurses (RN), several Registered Practical Nurses (RPN), several Personal Support Workers (PSW), the Food Services Supervisor (FSS), the Support Services Manager (SSM) and several residents.

During the course of the inspection, the inspector(s) reviewed the staff training log for 2013/14, the inventory of cleaning supplies on housekeeping carts, did several walking tours and observed a number of meal services, care provided to residents on several shifts, use of the mechanical lifts, interactions between residents and staff and housekeeping cleaning procedures.
