Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has falled to comply with LTCHA, 2007 S.O. 2007, c.8, s. 44. Authorization for admission to a home

Specifically failed to comply with the following subsections:

- s. 44. (7) The appropriate placement co-ordinator shall give the Ilcensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,
- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements:
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or
- (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).
- s. 44. (9) If the licensee withholds approval for admission, the ilcensee shall give to persons described in subsection (10) a written notice setting out,
- (a) the ground or grounds on which the licensee is withholding approval;
- (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care;
- (c) an explanation of how the supporting facts justify the decision to withhold approval; and
- (d) contact Information for the Director. 2007, c. 8, s. 44. (9).

## Findings/Faits saillants:

- 1. A letter indicating refusal of admission was received. The reason given for the refusal does not meet the requirements of the LTCHA as it does not indicate refusal based on the home lacking the physical facilities necessary to meet the applicant's care requirements or the staff of the home lacking the nursing expertise necessary to meet the applicant's care requirement. The licensee failed to ensure that an application is approved unless the home lacks the physical facilities necessary to meet the applicant's care requirements and the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements. [LTCHA 2007, S.O. 2007, c.8, s.44(7)]
- 2. Once the refusal letter was received, a discussion was held between Inspector #158 and the home. The home was directed to resubmit the letter of refusal this time providing additional detail. This second letter of refusal was received. This second letter again does not meet the requirements of the LTCHA, the explanation does not justify how the supporting facts relate to the home's lack of physical facilities. It describes the applicant's medical history and condition. An explanation of how these supporting facts justify the decision to withhold approval is not provided. The licensee failed to provide a full explanation of how the supporting facts justify the decision to withhold approval for this applicant's admission. [LTCHA 2007, S.O. 2007, c.8, s.44(9)(c)]
- 3. The second refusal letter was reviewed. In addition to not meeting legislative requirements for justifying refusal this second letter does not include the contact information for the Director. The licensee failed to ensure if approval for admission is withheld, written notice setting out the contact information for the Director is provided. [LTCHA 2007, S.O. 2007, c.8, s.44(9)(d)]
