The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 6th -8th, 2014

TAKE NOTE: This inspection was in follow up to two Compliance Orders, both of which are complied as a result of this inspection. One was related the front door alarm set up (O. Reg. 79/10, s. 9 (1) 1. iii), the other related to the resident-staff communication and response system (O. Reg. 79/10, s. 17. (1)). Due to technical issues, this inspection report does not identify both complied Compliance Orders in the final section of this report, where such information would typically be found. Therefore, the following serves to clarify that in addition to the Compliance Order referred to in the last section of this report (related to the front door alarm set up), the following Compliance Order (related to the resident-staff communication and response system) is also complied:

Requirement - O. Reg. 79/10, s. 17 (1); Compliance Order last issued by Inspector #133, as CO#003, as a result of inspection #2014_304133_0008. This Compliance Order had also been issued in the past as a result of inspection #2013_204133_0026 and # 2012_099188_0005.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Assistant Director of Environmental Services, the Director of Environmental Services, registered and non registered nursing staff, and residents.

During the course of the inspection, the inspector(s) tested the new resident-staff communication and response system in resident bedrooms and common areas throughout all areas of the home. This testing included verification that associated equipment, such as pagers and dome lights outside of resident bedrooms, were also functioning as required. As well, the inspector tested the new front door alarm and verified that all aspects of the set up are compliant.
