1. The home did not ensure that one resident's right to be properly sheltered, fed clothed, groomed and cared for in a manner consistent with his or her needs was promoted. One resident was observed with food on their clothing and shoe. The resident's hair was unkempt. This observation was confirmed by one staff. [s. 3. (1) 4.]

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15. Accommodation services

Specifically failed to comply with the following:

- s. 15. (2) Every licensee of a long-term care home shall ensure that,
- (a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8, s. 15 (2).
- (b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and 2007, c. 8, s. 15 (2).
- (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

Findings/Faits saillants:

- 1. The licensee did not ensure that the home, furnishings and equipment are kept clean and sanitary. One resident's wheelchair foot rest was observed heavily soiled with food crumbs. This observation was confirmed by one staff. [s. 15. (2) (a)]
- 2. The seat to one resident's wheelchair was observed heavily soiled with food crumbs. This observation was confirmed by one staff. [s. 15. (2) (a)]
