The licensee has failed to ensure that when withholding approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, the ground or grounds on which the licensee is withholding approval; a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; an explanation of how the supporting facts justify the decision to withhold approval; and contact information for the Director. 2007, c. 8, s. 44 (9).

This inspection was initiated related to a complaint from the Central East Local Health Integration Network (LHIN), received on a specified date. Complaint log #008795-18 related to applicant #001 pertained to withholding approval for admission to Fairview Lodge Long Term Care Home (LTCH).

A review of applicant #001's application and an interview with Placement Coordinator #100 with the Central East LHIN identified that applicant #001 required placement in a Long Term Care Home.

An application for admission was made to Fairview Lodge LTCH. The refusal letter dated a specified date, from Fairview Lodge LTCH home for applicant #001 was reviewed by Inspector #571. The refusal letter indicated that approval to the LTCH was withheld related to applicant #001's history and specified responsive behaviours.

During an interview with the Director of Care they acknowledged that the letter did not include sufficient detail, as required, for withholding an approval of admission.

The letter did not provide for a detailed explanation of the supporting facts, as they related both to the home and to the applicant's condition and requirements for care, an explanation of how the supporting facts justify the decision to withhold approval or the contact information for the Director.
