The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): June 1 and 2, 2017

A follow up inspection (2017-539120-0001) was previously conducted on January 4, 2017, to determine whether several Orders issued during the Resident Quality Inspection (2016-265526-0010) conducted May 10, 2016, were addressed. Several Orders were noted to remain outstanding and therefore three new Orders were issued. Order #001 was issued related to bed safety assessments and Orders #002 and #003 were issued related to staff training (pain management and reporting requirements if abuse observed). For this inspection, all three Orders and the required conditions were determined to have been addressed.

Order #002 was issued during a Resident Quality Inspection (2017-544527-0003) beginning on February 8, 2017, related to staff training and mandatory programs (Falls Prevention, Skin and Wound Care, Continence and Bowel Care and Pain Management). The conditions required in the Order were determined to have been addressed.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Maintenance person and personal support workers.

During the course of the inspection, the inspector toured the home, observed the bed systems, reviewed resident clinical records, policies and procedures and staff attendance records for various in home education and training sessions.
