**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): June 8 - 10, 2020.**

**The following intakes were inspected on during this Follow up inspection:**

**- One intake related to compliance order (CO) #001 that was issued during inspection #2020\_657681\_0001 for s. 71 (1) of the Ontario Regulation 79/10, specific to ensuring that the home's menu, including the menus for therapeutic and texture modified diets, were reviewed and approved by one of the home's registered dietitians.**

**- One intake related to CO #002 that was issued during inspection #2020\_657681\_0001 for s. 11 (1) of the Long-Term Care Homes Act, specific to ensuring that there was an organized program of nutrition care and dietary services that met the daily nutrition needs of the residents.**

**A Critical Incident inspection, #2020\_657681\_0004, was conducted concurrently with this inspection.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Director of Dietary Services, Registered Dietitians (RDs), Dietary Aides, and residents.**
