During the course of the inspection, the inspector(s) spoke with the Administrator, the Interim Director of Care, four Registered Nurses, three Registered Practical Nurses, three Personal Support Workers (PSW), and one Dietary Aide.

During the course of the inspection, the inspector(s) reviewed a sample of four Resident clinical records and the Daily Infection Control Surveillance Forms for each home area. Observed each home area for Infection Control Precaution signs.
