**Specifically failed to comply with the following:**

- (a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8, s. 15 (2).
  - (b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and 2007, c. 8, s. 15 (2).
  - (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

**Findings/Faits saillants :**

1. In 3 resident rooms, 6 pillows with the plastic covering cracked and one with an open end.
2. In a resident room, the door frame guard at the room door, was broken and protruding into the entrance.
3. In a resident room, noted large holes in the room walls by the entrance. [s. 15. (2) (c)]

**Additional Required Actions:**

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that residents are not at risk from preventive and remedial maintenance not being carried out, to be implemented voluntarily.***
