1. The licensee has failed to protect 2 residents from abuse.

Resident record's revealed that on eight occasions alleged abuse did occur over a 12 month period involving the same 3 residents.

The progress notes used to determine the above were provided by the Administrator.

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure residents are protected from abuse, to be
implemented voluntarily.***

**WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s.
76. Training**

Specifically failed to comply with the following:

**s. 76. (4) Every licensee shall ensure that the persons who have received
training under subsection (2) receive retraining in the areas mentioned in that
subsection at times or at intervals provided for in the regulations. 2007, c. 8, s.
76. (4).**

Findings/Faits saillants :

1. The licensee has failed to ensured that all staff receive training annually related to the home's Resident Non-Abuse Program.

One Personal Support Worker last had training December 12, 2011 and one Personal Support Worker last had training December 12, 2012.

The Staff Educator confirmed the 2 personnel identified above did not receive annual retraining in the home's "Resident Non-Abuse S.T.O.P. (Abuse) Intervention" program. [s. 76. (4)]
