**During the course of the inspection, the inspector(s) spoke with the Administrator, the Assistant Director of Care (ADOC), a Minimum Data Set (MDS) coordinator, registered nursing staff and non-registered nursing staff, residents and family members.**

**In addition, the inspector reviewed resident health care records, documents related to the home's education of prevention of abuse and reporting requirements documentation, investigation documentation into each critical incident reported by the home, reviewed documentation tool for internal reporting of alleged, suspected or witnessed abuse or neglect of a resident, reviewed internal incident report document, the new 24 hour plan of care documentation tool, policies related to prevention of abuse and reporting of abuse. The inspector observed resident to resident interactions, and aspects of resident care and interactions with staff.**
