The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 4 - 6, 9, 2018.

Two intakes were inspected during the inspection, CIS log #020020-17 (2882-000039-17) related to staff to resident alleged abuse and CIS log #011535-17 (2882-000030-17) related to resident to resident abuse.

This inspection was completed concurrently with a complaint inspection log #010361-17, related to staffing concerns in the home.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nursing Staff, Dietary Staff, Personal Support Workers (PSW) and residents.

The inspector observed the provision of care and services to residents, staff to resident interactions, resident to resident interactions, residents' environment and reviewed resident health care records and the home's investigation records.
