**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**The following intakes were completed as part of this Critical Incident System (CIS) inspection:**

- Log 024030-20 / CIS 2882-000029-20 was related to the fall of a resident.
- Log 024728-20 / CIS 2882-000030-20 and log 000423-21 / CIS 2882-000002-21 were related an incident that caused an injury to a resident for which the resident was taken to hospital and that resulted in a significant change in their health status.

**During the course of the inspection, the inspector(s) spoke with a Personal Support Worker, a Housekeeper, Registered Practical Nurses, Registered Nurses, the Physiotherapist, the Life Enrichment Manager, the Environmental Services Manager, the Director of Infection Prevention and Control, the Director of Care and the Administrator.**
