The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): February 26, 2013

It is noted that three Critical Incident inspections were conducted during this one inspection: logs # O-001111-12, #O-001396-12 and #O-002118-12

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Assistant Director of Care, RAI Coordinator, several Registered Nurses, several Registered Practical Nurses, several Personal Support Workers, a Life Enrichment staff member, a housekeeper and to several residents.

During the course of the inspection, the inspector(s) reviewed several residents health care records, observed resident care and service, reviewed the home's Respect Always: Abuse/Neglect of Residents by Staff policy (revised March 2012) as well as the home's Respect Always 2012 education plan, reviewed the home's internal investigation report related to an incident of alleged resident abuse log #O-001396-12, reviewed three critical incident reports.
