The purpose of this inspection was to conduct a Director Order Follow Up inspection.

This inspection was conducted on the following date(s): January 14-18, 21-25, 2019.

DO log #016148-18 related to plan of care, medication administration and bed rail assessments.

Inspector Amanda Owen #738 was present during this inspection.

During the course of the inspection, the inspector(s) spoke with the Senior Executive Director (ED), the Director of Resident Care (DRC), the Assistant Director of Resident Care (ADRC), the Senior Director of Nursing (DON), Registered Nurses (RNs), Registered Practical Nurses (RPNs), a Personal Support Worker (PSW) and residents.

A follow up inspection to a Director Order (DO#001 served on 2018-07-05) concluded that the Director Order was complied with (s. 6.).

In addition, the inspector observed medication administration, and reviewed the plan of care for the identified residents and the home's related documentation and policies.
