**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**This inspection was conducted on the following date(s): August 31 and September 1, 2021.**

**During the course of the inspection, the inspector(s) spoke with the Executive Director (ED), the Director of Care (DOC), the Maintenance Lead, a Housekeeper, a Registered Practical Nurse (RPN), Personal Support Workers (PSWs), and residents.**

**The inspectors also observed resident rooms and common areas, observed residents and the care provided to them, reviewed health care records and plans of care for identified residents, and reviewed the home's temperature records.**

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 21. Air temperature  
Specifically failed to comply with the following:**

**s. 21. (3) The temperature required to be measured under subsection (2) shall be documented at least once every morning, once every afternoon between 12 p.m. and 5 p.m. and once every evening or night. O. Reg. 79/10, s. 21 (3).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that the air temperature was measured and documented in writing in at least two resident bedrooms in different parts of the home, and one resident common area on every floor of the home once every evening or night.

A review of the home's temperature records for August 2021, identified that the home was not measuring and documenting in writing the air temperatures at least once every evening or night.

In an interview with the Director of Care (DOC), they confirmed that the home was not measuring the air temperatures every night or evening.

There was minimal risk of harm to residents related to the air temperature not being monitored in the evening or night.
