The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): December 10 - 14, and December 18 - 20, 2018.

The following intakes were completed in this Follow up Inspection:

- one intake related to CO #001 from Inspection report #2017_486653_0021, s. 71. (4), of the Ontario Regulation 79/10, specific to planned menu items not being offered and available at each meal and snack,
- one intake related to CO #002 from Inspection report #2017_486653_0021, c.8, s.6. (7) of the Long-Term Care Homes Act (LTCHA), 2007, specific to care set out in the plan of care not being provided to the resident as specified in the plan, and
- one intake related to CO #003 from Inspection report #2017_486653_0021, c.8, s.6. (4) of the LTCHA, 2007 S.O. 2007, specific to staff and others involved in the different aspects of care of the resident collaborate with each other in the assessment of the resident so that their assessments are integrated and are consistent with and compliment each other, and in the development and implementation of the plan of care so that the different aspects of care are integrated and are consistent with and compliment each other.

A Critical Incident System (CIS) Inspection #2018_565647_0035 was conducted concurrently with this follow up Inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Assistant Director of Care (ADOC), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), Restorative Care Coordinator, Nursing Rehabilitation Coordinator, Residents, and Substitute Decision Makers.
