The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): April 20-23, 2021, and April 26, 2021.

-One log, which was related to compliance order #001 from inspection report 2020_824736_0025, where the home was ordered to comply with section 107 subsection 3 of the Ontario Regulations (O.Reg), 79/10, specifically to ensure that the Director was informed of all incidents of missing or unaccounted for controlled substances within one business day, with a compliance due date of January 29, 2021.

A Critical Incident System Inspection #2021_745690_0011 was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurses (RN), and Registered Practical Nurses (RPN).

The Inspector(s) also conducted a daily tour of resident care areas, reviewed internal documents, critical incident submissions, as well as licensee policies, procedures and programs.
