The purpose of this inspection was to conduct a Resident Quality Inspection.

This inspection was conducted on the following date(s): July 3, 4, 5, 6, 9, 10, 11, 12, 13, 16, 17, 18, 19, 20, and 23, 2018

The following critical incident logs were inspected: Log #002382-18 related to a resident fall with injury, Log #001513-18 related to acute respiratory outbreak, Log # 008752-18 related to alleged staff to resident abuse.

Also inspected were complaint log #015983-18 related to an alleged medication incident and Log #016386-18 related to heat concerns.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Nursing (DON), the Assistant Director of Nursing (ADON), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), the RAI Coordinator, the Food Service Supervisor, the Nurse Practitioner, Dietary Aides, the Activation Coordinator, Resident Council President, Family Council President, family members, and residents.

During the course of the inspection, the inspector conducted a tour of the home, observed medication administration and written processes for handling of medication incidents and adverse drug reactions, reviewed resident health care records, observed and reviewed infection control practises, resident and family council minutes, the licensee's policy related to falls prevention, and the home's staffing schedules for the nursing department.
