The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): September 22, 2015

A Resident Quality Inspection (2014-247508-0033) was previously conducted October 28-November 17, 2014, at which time Orders #001 and #004 were issued related to the home's maintenance program. For this follow up inspection, all conditions laid out in the Orders were met.

Non-compliance was also identified in October 2014 with respect to the resident-staff communication and response system, window restricting hardware, housekeeping and laundry services. The licensee was requested to voluntarily develop a plan to address the non-compliance. During this visit, the non-compliance was confirmed and observed to have been completed or was being addressed.

Concurrently with this inspection, a complaint inspection was also completed related to high indoor air temperatures for the month of June 2015. Non compliance was not identified.

During the course of the inspection, the inspector(s) spoke with the Administrator, contracted service maintenance consultant, in-home maintenance person, housekeepers, registered and non-registered staff.

During the course of the inspection, the inspector toured all home areas, common spaces, tub/shower rooms, dining rooms and basement area, reviewed maintenance service reports, maintenance logs, temperature logs, thermometers, maintenance policies and procedures and work schedules and verified work completed within the home.
