During the course of the inspection, the inspector(s) spoke with the administrator, resident and environmental services supervisor regarding air temperatures in the home. A discussion was held regarding the need to increase the number of ambient air thermometers throughout the home for monitoring purposes.

During the course of the inspection, the inspector(s) took air temperature readings in an identified resident room, verified temperatures at 3 nurse's stations on the 2nd floor and reviewed air temperature monitoring logs.
