WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 30. General requirements

Specifically failed to comply with the following:

s. 30. (2) The licensee shall ensure that any actions taken with respect to a resident under a program, including assessments, reassessments, interventions and the resident's responses to interventions are documented. O. Reg. 79/10, s. 30 (2).

Findings/Faits saillants :

1. The licensee did not ensure that any actions taken within respect to a resident under a program, including assessments, reassessments, interventions and the resident's responses to interventions were documented.

A. A physician's order for wound care was written for resident #001 in December 2013, which indicated that care was to be done three times a day. Reviewed the plan of care for the resident and noted that the treatment, ordered in December 2013, was not included on the treatment administration records (TAR) for January 2014, and therefore were not being documented as being completed. From January 1, 2014 to January 21, 2014, staff did not document that the wound care was completed.

Registered staff confirmed the wound care orders were missing from the TAR and not being documented. [s. 30. (2)]
