The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 9, 2016

An inspection (2015-189120-0092) was conducted on November 16 & December 2, 2015 in response to a report submitted by the licensee regarding a resident who became injured from an inappropriate transfer using a mechanical lift. Non-compliance was identified relating to staff training in the use of mechanical lifts and transfer techniques (Order #003), falls prevention and pain management. Three separate Compliance Orders were issued. For this follow-up inspection, the conditions laid out in Order #003 were verified as completed.

A Resident Quality Inspection (2016-323130-0007) was previously conducted March 8 to 30, 2016 at which time Order #004 was issued related to safety issues identified in the home. For this follow-up visit, the conditions laid out in the Order were verified as completed.

During the course of the inspection, the inspector(s) spoke with the administrator, maintenance manager and staff educator.

During the course of the inspection, the inspector conducted a tour of the 1st and 2nd floor and reviewed the licensee's lift and transfer program and staff attendance records for lift and transfer training.
