**WN#1:** The Licensee has failed to comply with: O.Reg. 79/10, s.73(1)(9)

**Every licensee of a long-term care home shall ensure that the home has a dining and snack service that includes, at a minimum, the following elements:** Providing residents with any eating aids, assistive devices, personal assistance and encouragement required to safely eat and drink as comfortably and independently as possible.

#### Findings:

1. Resident #1 was not positioned in a comfortable position at the lunch meal service in August, 2010. No assistance was provided to encourage the resident to change positioning in order to reach the table comfortably.

**WN#2:** The Licensee has failed to comply with: O.Reg. 79/10, s. 88(2)

**The licensee shall ensure that immediate action is taken to deal with pests.**

#### Findings:

1. There were a large number of house flies noted behind the steam table in the first floor dining room during lunch and supper service on August 11, 2010 and throughout the kitchen on August 12, 2010. The garbage is stored outside the building near the receiving door. The door is propped open while goods are being received allowing pests to gain access. The Home did not take immediate action to address this issue on August 11, 2010.

**VPC – pursuant to LTCHA, 2007, S.O. 2007, c.8, s. 152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure immediate action is taken to deal with pests, to be implemented voluntarily.**
