Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 23. Every licensee of a long-term care home shall ensure that staff use all equipment, supplies, devices, assistive aids and positioning aids in the home in accordance with manufacturers' instructions. O. Reg. 79/10, s. 23.

Findings/Faits saillants :

1. The licensee has failed to ensure that staff use all equipment, supplies, devices, assistive aids and positioning aids in the home in accordance with manufacturers' instructions.

An identified resident who had been assessed with altered skin integrity, was found to be using a therapeutic surface that was not properly maintained.

The residents' plan of care indicated that staff are to ensure the therapeutic surface is properly maintained while in use.

Interview with two Registered Staff indicate that the expectation is that the Personal Care Workers are to check the therapeutic surface to ensure it is properly maintained. Two Personal Care Workers indicated that they had not received training on how to ensure the therapeutic surface was properly maintained.

The Director of Care, Administrator and Corporate Educator confirmed that all staff had not received training on the use of the therapeutic surface to ensure that staff use the equipment according to the manufacturers' instructions. [s. 23.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all staff use all equipment, supplies, devices, assistive aids and positioning aids in the home in accordance with manufacturers' instructions, to be implemented voluntarily.
