1. The licensee did not ensure that every resident was treated properly, sheltered, fed, clothed, groomed and cared for in a manner consistent with their needs.
 - a) One resident fell from their wheelchair to the floor which initially resulted in bruising to the head and chest.
 - b) Documentation in the resident's clinical record over the next ten days includes ongoing nursing assessments that identify new resident behaviours.
 - c) Ongoing pain assessments during this time period suggested mild pain with pain assessment scores varying between 2/10 and 4/10.
 - d) PRN non-narcotic medication was administered and not effective during the provision of care.
 - e) Bruising extended over this same period of time with noticeable swelling.
 - f) The resident was not transferred to hospital for assessment until 10 days post fall when they were diagnosed with a fracture.
 - g) Management personnel were not able to provide confirmation of the rationale for not transferring the resident to hospital for assessment until 10 days post fall due to a change in their health status.[s.3.(1) 4]

Additional Required Actions:

the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that every resident will be treated properly,
sheltered, fed, clothed, groomed and cared for in a manner consistent with their
needs., to be implemented voluntarily.***
