The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with seven residents, the Administrator, Director of Care, two RPN's and one PSW.

During the course of the inspection, the inspector(s) reviewed the home Hot Weather Related Illness Policy, the resident home area posted listing of resident risk scores for hot weather related illnesses, completed temperature and humidex readings in eleven resident rooms, reviewed eleven resident health records and observed each resident room and two corridors for the presence of fans and dehumidifiers.
