During the course of the inspection, the inspector(s) reviewed the home's pest control program, staffing schedules, servery cleaning protocols/checklists, and toured home areas including dining rooms and serveries.

1. The licensee has not ensured that the homes servery equipment has been kept clean and sanitary.

During the inspection the following concerns were identified on the 2nd floor servery:

- water pooling under the dishwasher
- plastic cup on floor behind dishwasher
- caked on food debris around seams of dishwasher
- build-up of dirt and food debris under rubber mats
- food splatter on servery counter rolling door
- china dishes, plastic dessert bowls and plastic lip plates had notable staining and significant wear
- several serving trays found with a white tape like residue along edges
- food debris on floor
- plastic cup on floor by rodent trap
- dead flies under ceiling light panel
- ceiling duct/fan edges were dusty and had significant build up around the base

The following concerns were identified in the Shallows Lane servery:

- food splatter noted on servery counter rolling door
- build up of debris along floor edging
- build up of food debris and white residue along dishwasher edges

The following concerns were identified in the Hillman Marsh servery:

- laminate on drawers and counter top peeling and/or missing
- dried food splatter on cupboard doors
- dishes with notable stains and wear

Two staff observed the identified concerns, both indicate that the home's expectation is for all serveries, equipment and home areas, to be clean and sanitary. [s. 15. (2) (a)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that the home's serveries and equipment is
kept clean and sanitary, to be implemented voluntarily.***
