Findings/Faits saillants:

The licensee has failed to ensure that the lighting requirements set out in the lighting table were maintained for home to which the 2009 design manual applies: In all other areas of the home, including resident bedrooms and vestibules, washrooms, and tub and shower rooms - Minimum levels of 322.92 lux.

During a previous RQI inspection, in 2017, there were resident complaints related to low lighting levels in three identified resident rooms.

The home was built before 2009 and therefore the table above applies. The home has 30 beds, 18 beds are private and 12 beds are semi/basic with two beds in them. All of the

resident rooms have a recessed pot light ceiling fixture approximately 10 inches in diameter, upon entrance into the rooms and contain 2 CFL bulbs with no covers. There is also the same recessed pot light fixture in the centre of each room/bed area. 19/30 of the resident rooms had an additional above the head of the bed, wall-mounted light fixture, approximately three feet long ballast lights, both upper and lower CFL tube lights in place and have frosted plastic cover, placed approximately five feet from the ground. All of the resident bathrooms have a similar recessed pot light fixture as the rooms but are only able to contain 1 CFL bulb and are placed above the toilet area. There is also an above the sink, wall mounted ballast light fixture, with a frosted plastic cover, approximately two feet in length and contain CFL tube lights. There are placed approximately three feet above the sinks. There were 11 resident beds that did not have an additional above the bed light fixtures in place, that would not meet the lighting lux levels. The new above bed light fixtures all had a three inch chain and a black push button on/off switch on the underside of the fixture. Residents in wheelchairs or lying in bed would not be able to access the light switches to turn those lights on or off.

On a specified date and time, the lighting levels were measured throughout the home using an Amprobe LM-120 light meter held approximately 3-4 feet from the ground, in identified private and semi-private/basic rooms. The day was overcast/cloudy outside. The hallways and common areas were not measured. All lights in each resident room and bathroom were turned on for approximately 5-10 minutes, all curtains available were closed, including any privacy curtains in any two bed resident rooms and all doors were also closed. The following resident rooms had lighting levels measured:

In an identified private resident room:

- -there was an additional light fixture over the head of the bed (HOB):
- -entrance of the room measured 360 Lux (L); HOB measured 1660 (L); the foot of the bed (FOB)/in front of closet measured 180 (L); entrance to bed area measured 390 (L); in front of the seating area measured 315 (L).
- -In the bathroom, in front of the sink area measured 320 (L); in front of the toilet area measured 305 (L).

In an identified resident semi-private room:

- -entrance of the room measured 320 Lux (L)
- -Specified Bed (there was no additional light fixture above the bed) the entrance of the bed measured 100 (L); HOB measured 140 (L); FOB measured 76 (L); in front of closet measured 70 (L); in front of the seating area measured 70 (L).
- -Specified Bed (there was an additional light fixture above the bed). In the bathroom, in

front of the sink area measured 315 (L); in front of the toilet area measured 275 (L).

In a second identified resident semi-private room:

- -entrance of the room measured 380 Lux (L)
- -Specified Bed (there was no additional light fixture above the bed) the entrance of the bed measured 60 (L); HOB measured 50(L); FOB & in front of the closet measured 25 (L); in front of the seating area measured 60 (L).
- -Specified Bed (there was an additional light fixture above the bed) the entrance of the bed measured 700 (L); HOB measured 700(L); FOB & in front of the closet measured 260 (L); in front of the seating area measured 270 (L).
- -In the bathroom, in front of the sink area measured 280 (L); in front of the toilet area measured 260 (L).

In a third identified resident semi-private room:

- -entrance of the room measured 320 Lux (L)
- -Specified Bed (there was no additional light fixture above the bed) the entrance of the bed measured 175 (L); HOB measured 115(L); FOB & in front of the closet measured 65 (L); in front of the seating area measured 65 (L).
- -Specified Bed (there was no additional light fixture above the bed) the entrance of the bed measured 40 (L); HOB measured 22 (L); FOB & in front of the closet measured 32 (L); in front of the seating area measured 85 (L).
- -In the bathroom, in front of the sink area measured 260 (L); in front of the toilet area measured 245 (L).

During an interview with resident #004 and resident #005 on a specified date, both indicated their rooms were dark, making it difficult to read without use of their personal light fixtures (i.e. table and floor lamps).

During an interview with resident #003 on a specified date, indicated "it is very dark in my room".

During an interview with resident #006 on a specified date, indicated "I have the new light fixture above my bed but I can't reach it to even turn it on".

During an interview with the DOC on a specified date, the DOC indicated awareness of low lighting concerns in the resident rooms and indicated the Director of Facility and Projects (DFP) had already begun adding new light fixtures in the resident rooms. The Administrator/DOC indicated she was unaware of how many resident rooms had already

been completed and would have to speak to the DFP for further information. The Administrator/DOC indicated awareness that the metal cords attached to the new above bed light fixtures were inaccessible for residents in wheelchairs or lying in their beds. The Administrator/DOC indicated they were still discussing which type of cord to be applied to them but had not yet started.

During an interview with the Director of Facility and Projects (DFP) on a specified date, the DFP indicated he has been working on putting up the new light fixtures over the residents' beds. The DFP indicated that he had completed approximately 20/30 beds at this time, was waiting for further funding to complete the remainder resident rooms and was not aware when this would occur. The DFP indicated previously, there was no above bed light fixture available for the resident beds. The DFP was also aware that at the previous RQI, low lighting levels were noted.

The licensee has failed to ensure that the lighting requirements set out in the lighting table were maintained in home as per the 2009 design manual, by ensuring that all resident rooms, including resident bedrooms were a minimum level of 322.92 lux. In addition, the new above-bed light fixtures that had been installed, did not have accessible pull cord/switch for residents in wheelchairs or lying in bed, rendering the residents unable to turn those lights on or off.
