Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 16-20, 2019.

The following intakes were inspected during this Critical Incident inspection:

- One log which was related to a critical incident the home submitted to the Director for failure of cooking equipment,
- Two logs which were related to critical incidents the home submitted to the Director for falls that resulted in a transfer to hospital.

A Complaint inspection, #2019_745690_0033, was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Nutrition manager, Registered Dietitian (RD), Executive Chef, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), and residents.

The Inspector(s) also conducted a daily tour of resident care areas, observed the provision of care and services to residents, reviewed health care records, internal investigation notes, as well as licensee policies, procedures and programs.
