Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): October 14, 15, 16, 19, 20, 23, 29 and 30, 2020 and November 2, 3, 4 and 5, 2020.

Log 018054-20 was related to concerns about the care of a resident.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Le non-respect des exigences de la Loi de 2007 sur les foyers de soins de longue durée (LFSLD) a été constaté. (une exigence de la loi comprend les exigences qui font partie des éléments énumérés dans la définition de « exigence prévue par la présente loi », au paragraphe 2(1) de la LFSLD.

Ce qui suit constitue un avis écrit de non-respect aux termes du paragraphe 1 de l'article 152 de la LFSLD.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 229. Infection prevention and control program

Specifically failed to comply with the following:

s. 229. (4) The licensee shall ensure that all staff participate in the implementation of the program. O. Reg. 79/10, s. 229 (4).

Findings/Faits saillants :

1. The licensee has failed to ensure that three staff members wore a face mask that covered their nose and mouth in accordance with the infection prevention and control program.

During the course of the inspection, video footage was reviewed that showed three staff members not wearing their face masks over their nose and/or mouth. The incidents occurred four times in resident #001's room.

The DOC stated that not wearing a face mask that covered the mouth and nose was a violation of the home's infection prevention and control program.

Not wearing a face mask that covered the wearers' mouth and nose presented a risk to resident #001 due to the COVID-19 pandemic.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff wear a face mask in accordance with the licensee's infection prevention and control program, to be implemented voluntarily.
