During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC)/Infection Prevention and Control (IPAC) Lead, Assistant Director of Nursing (ADOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Covid-19 Screener, Covid-19 Tester, Housekeepers, Recreation Assistant, Manager of Environmental Services, Physiotherapist, Physiotherapy Assistant, and residents.

During the course of the inspection the inspector observed infection prevention and control practices and reviewed clinical health records, home policies and other pertinent documents.
