The purpose of this inspection was to conduct an Other inspection.

This inspection was conducted on the following date(s): December 2, 2014

The purpose of this inspection was to follow up on 37 residents from Fairview Lodge admitted on a interim temporary basis to Hillsdale Estates after the fire. The 37 residents were admitted on three different floors either in the Television Room (2 residents per room) or in the Activity Room (6 residents per room).

During the course of the inspection, the inspector(s) spoke with the Director of Care, the Resident Care Coordinator, one Registered Nurse and one Registered Practical Nurse, several resident and several family members.

During the course of the inspection, the inspector(s) reviewed a few residents health care records and observed care and services provided to residents.
