**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): May 17, 2018**

An inspection (2017-539120-0051) was previously conducted on August 25, 2017 and non-compliance identified related to the licensee's bed safety program. A compliance order (#001) was issued on September 1, 2017, with a compliance date of December 31, 2017. For this follow-up visit, the conditions laid out in the compliance order have been met.

During the course of the inspection, the inspector(s) spoke with the Administrator, Manager of Program Development, a registered nurse, personal support worker and family member.

During the course of the inspection, the inspector toured two second floor home areas and observed resident bed systems, reviewed the licensee's bed safety policies and procedures, resident clinical bed rail use assessments, residents' plan of care, staff training materials and internal monitoring audits.
