The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): September 25, 2015

A Resident Quality Inspection (2015-240506-0008) was previously conducted April 8-16, 2015 at which time Order #002 was issued for non-compliance related to the home's bed systems. For this follow-up visit, the conditions laid out in the Order were met.

Non-compliance was also identified in April 2015 with respect to lighting, the resident-staff communication and response system and door security. The licensee was requested to voluntarily develop a plan to address the non-compliance. During this visit, the non-compliance was confirmed and observed to have been completed or addressed.

During the course of the inspection, the inspector(s) spoke with the Administrator and maintenance person, tested the resident-staff communication and response system, measured resident bedroom lighting levels, tested exit door alarms, toured random resident washrooms and soiled utility rooms, reviewed bed system audit records, bed safety policies and procedures, resident bed safety clinical assessment forms and observed 9 residents in bed where one or more bed rails were in engaged or in use.
