**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 229. Infection prevention and control program**

**Specifically failed to comply with the following:**

**s. 229. (4) The licensee shall ensure that all staff participate in the implementation of the program. O. Reg. 79/10, s. 229 (4).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that all staff participated in the implementation of the Infection Prevention and Control (IPAC) program.

The inspector observed that a screener at the entrance of the home was not wearing the required Personal Protective Equipment (PPE) including a gown and eye protection, while performing Rapid Antigen Test (RAT).

The screener and Director of Care (DOC) verified that the screener was required to wear full PPE while performing RAT for people who enter the home.
