1. The licensee has failed to ensure that when withholding approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, the ground or grounds on which the licensee is withholding approval; a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care and an explanation of how the supporting facts justify the decision to withhold approval.

An application for long term care placement was submitted by the community care access centre (CCAC) for resident #001.

On an identified date, resident #001 received written notice that the home was withholding the approval of admission.

An interview held with the Director of client services indicated that the home was unable to approve the admission based on specified supporting facts. The Director of client services indicated that the supporting facts were not included within the letter.

Further interviews held with the Director of client services and the client services assistant confirmed that the written notice did not provide a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care and an explanation of how the supporting facts justify the decision to withhold approval.
