The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The licensee has failed to comply with the LTCHA, 2007, S.O. 2007, c.8, s.3.(1)1. Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:

1. Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity.

Findings:

In 2011, 2 personal service workers were assisting a resident when one worker made an inappropriate and derogatory statement to the other worker regarding the elderly. This statement was made disrespectfully in the presence of the resident. The home conducted an investigation and took appropriate actions.

WN #2: The Licensee has failed to comply with O. Reg. 79/10, s. 36. Every licensee of a long-term care home shall ensure that staff use safe transferring and positioning devices or techniques when assisting residents.

Findings:

In 2011, a personal service worker transferred a resident using an inappropriate lift for the resident's condition, compromising the safety of the resident. Another worker witnessed the unsafe transfer technique and reported it to their supervisor. According to the Director of Care, the worker admitted that they knew that the decision to use one lift over another was not appropriate and that it could have compromised the safety of the resident. The resident was not injured. The home conducted an investigation and took appropriate actions.
