The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with O. Reg. 79/10, s. 90(2)(k):

The licensee shall ensure that procedures are developed and implemented to ensure that, if the home is not using a computerized system to monitor the water temperature, the water temperature is monitored once per shift in random locations where residents have access to hot water.

Findings:

29 October 2010

Hot water temperature logs from night shift 01 August 2010 to night shift 29 October 2010 had 75 entries missing out of a possible 268. This accounted for approximately 28% of entries not recorded. No other documentation indicated the water temperature was monitored once per shift in random locations where residents have access to hot water.
