**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15. Accommodation services
Specifically failed to comply with the following subsections:**

s. 15. (2) Every licensee of a long-term care home shall ensure that,
(a) the home, furnishings and equipment are kept clean and sanitary;
(b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and
(c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

Findings/Faits saillants :

1. On December 13, 2011 at 1600 hrs, the inspector observed that a ceiling light fixture in the third floor East shower room was browned and appeared to have been burned and melted.

On December 15, 2011, the home's Administrator informed the inspector that the light fixture in the shower room had been reported damaged in September 2011, it had been determined that a new fixture would be needed and it had been ordered. In the meantime the light bulb had been changed, because it was thought to be too strong and had burned the fixture. The home's Assistant Administrator informed the inspector that the fixture had arrived, but the home was awaiting an electrician to install it.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the light fixture in the third floor East shower room is repaired or replaced, to be implemented voluntarily.
