Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 79. Posting of information

Findings/Faits saillants :

1. On Aug. 30, 2011 at 14:00, the Inspector failed to find the following items posted within the home:
 - a) Ministry of Health and Long-Term Care Inspection Report # 2010_109_2860_04Oct104709, from an inspection conducted on September 28 and 29, 2010.
 - b) The home's policy to promote zero tolerance of abuse and neglect.
 - c) Notification of the home's policy to minimize the restraining of residents, and how a copy of the policy could be obtained.
 - d) Most recent minutes of Residents' Council meetings with consent of Residents' Council.
 - e) Explanation of the protections afforded under section 26. (Whistle-blowing protection)

On Sept 1, 2011 inspector noted in the lobby, the posted copy of the home's Abuse prevention policy, an explanation of the protections afforded under section 26 (whistle-blowing protection), and a copy of the home's Minimizing Restraints policy. Note that these documents were posted on Aug 31, 2011, after the Administrator was informed by the inspector that they were missing.
