**Inspection Summary/Résumé de l'inspection**

**The purpose of this inspection was to conduct a Complaint inspection.**

**This inspection was conducted on the following date(s): September 29, 30, October 1, 2, 5, 6, 7, and 8, 2020.**

**This inspection was conducted concurrently with Critical Incident System inspection # 2020\_739694\_00024.**

**The following intakes were inspected;  
Log #017768-20, related to prevention of abuse,  
Log #013412-20, and Log #019394-20, related to care concerns,  
and Log #019343-20, related to medication administration.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), PSW Coordinator, and residents.**

**The inspector also toured the home, observed the provision of care and services, reviewed relevant documents, including but not limited to clinical records, staff schedules, policies and procedures, and investigation notes.**

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 23. Licensee must investigate, respond and act**

Specifically failed to comply with the following:

- s. 23. (1) Every licensee of a long-term care home shall ensure that,
- (a) every alleged, suspected or witnessed incident of the following that the licensee knows of, or that is reported to the licensee, is immediately investigated:
    - (i) abuse of a resident by anyone,
    - (ii) neglect of a resident by the licensee or staff, or
    - (iii) anything else provided for in the regulations; 2007, c. 8, s. 23 (1).
  - (b) appropriate action is taken in response to every such incident; and 2007, c. 8, s. 23 (1).
  - (c) any requirements that are provided for in the regulations for investigating and responding as required under clauses (a) and (b) are complied with. 2007, c. 8, s. 23 (1).

**Findings/Faits saillants :**

1. The licensee failed to ensure that an allegation of improper care of a resident was immediately investigated.

A resident reported concerns regarding improper care to staff and it was documented in the resident's progress notes, but there was no investigation conducted into the incident.

By not investigating the accusation there was a potential for ongoing concerns related to the resident's care.

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all incidents of improper care are immediately investigated, to be implemented voluntarily.***

**WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 50. Skin and wound care**

**Specifically failed to comply with the following:**

- s. 50. (2) Every licensee of a long-term care home shall ensure that,**
- (b) a resident exhibiting altered skin integrity, including skin breakdown, pressure ulcers, skin tears or wounds,**
- (i) receives a skin assessment by a member of the registered nursing staff, using a clinically appropriate assessment instrument that is specifically designed for skin and wound assessment,**
  - (ii) receives immediate treatment and interventions to reduce or relieve pain, promote healing, and prevent infection, as required,**
  - (iii) is assessed by a registered dietitian who is a member of the staff of the home, and any changes made to the resident's plan of care relating to nutrition and hydration are implemented, and**
  - (iv) is reassessed at least weekly by a member of the registered nursing staff, if clinically indicated; O. Reg. 79/10, s. 50 (2).**

**Findings/Faits saillants :**

1. The licensee failed to ensure that a resident received a skin and wound assessment by registered nursing staff for a skin concern.

During the inspection, a resident was observed with a skin concern. The home's practice was to complete an initial skin and wound assessment for all skin concerns. There was no skin and wound assessment completed for the resident's skin concern . By not having an assessment completed, there was no regular monitoring to ensure the areas were healing and there was no underlying injury.

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that when a resident has altered skin integrity, they receive a skin and wound assessment by a registered nursing staff, to be implemented voluntarily.***

**WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 135. Medication incidents and adverse drug reactions**

**Specifically failed to comply with the following:**

**s. 135. (2) In addition to the requirement under clause (1) (a), the licensee shall ensure that,**

**(a) all medication incidents and adverse drug reactions are documented, reviewed and analyzed; O. Reg. 79/10, s. 135 (2).**

**(b) corrective action is taken as necessary; and O. Reg. 79/10, s. 135 (2).**

**(c) a written record is kept of everything required under clauses (a) and (b). O. Reg. 79/10, s. 135 (2).**

**Findings/Faits saillants :**

1. The licensee failed to ensure that all medication incidents involving a resident were documented, reviewed and analyzed.

Medication was left in a resident's room. On two additional occasions medication was found on the floor of a resident's room by a visitor. The registered staff documented that the medication was discarded, but no actions were taken. A medication incident report was not completed, and the physician was not notified. The resident's electronic medication administration record (eMAR) showed that all doses were signed as given to the resident, even though they appeared to have missed a dose of two medications. There was potential for continued medication incidents of the same nature to occur if incidents were not documented, reviewed and analyzed with corrective actions.

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all medication incidents are documented, reviewed and analyzed, to be implemented voluntarily.***
