The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 9,10, 14, 15, 2020.

The following intakes were inspected:

Log #023057-20 related to Abuse and Neglect;

Log #022555-20 follow-up to CO #001 from inspection #2020_739694_0024 related to resident plan of care, specifically, safe lift and transfer interventions; providing assistance required for dressing and bathing; retraining of all staff on safe lift and transfers.

During the course of the inspection, the inspector(s) spoke with the ED, DOC, PSW Supervisor, RPN and a PSW.

The Inspector also observed the provision of resident care, staff-resident interactions, reviewed Resident's clinical records, the Homes investigation notes, Critical Incident reports and completed staff interviews.

The following Inspection Protocols were used during this inspection: Falls Prevention Prevention of Abuse, Neglect and Retaliation

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director

Specifically failed to comply with the following:

s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:

1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).

Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).
 Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).

4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2). 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).

Findings/Faits saillants :

1. The licensee has failed to comply with s. 24 (1) 2. in that a person who had reasonable grounds to suspect abuse of a resident, failed to report the alleged abuse immediately to the Director in accordance with s. 24 (1) 2 of the LTCHA. Pursuant to s. 152 (2) the licensee is vicariously liable for staff members failing to comply with subsection 24 (1).

An allegation was made by a PSW that another PSW had spoken inappropriately to a resident, and that on another occasion the same PSW may have caused physical injury to the resident. Approximately two months later these allegations were disclosed to the ED who initiated an investigation. Given the delay in staff reporting, the alleged incidents were not reported to the Director until approximately two months after they occurred.

Not reporting the suspected abuse immediately put the resident and other residents at further risk of harm from the PSW.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that anyone who has reasonable grounds to suspect that abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident immediately reports the suspicion and the information upon which it is based to the Director. S.24 (1), to be implemented voluntarily.
