The Inspector also conducted a tour of the home, observed infection prevention and control practices, the provision of resident care, staff-resident interactions, conducted resident and staff interviews, reviewed resident's clinical records, critical incident system reports, and the homes staff training records pertaining specifically to hand hygiene and donning/doffing of Personal Protective Equipment (PPE).
