WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants:

1. The licensee failed to ensure that the care set out in the plan of care is provided to the resident as specified in the plan.

The plan of care for resident 001 details that the resident's nutrition and hydration needs are met solely through tube feeding. The medication administration record for resident 001 indicates that the resident is to receive a tube feeding supplement over a specified period of time and that the supplement is to be held for one hour before and after administering an identified medication. In an interview, the director of care revealed that on an identified date, resident 001 was administered the medication as ordered, however the tube feed was not turned on one hour post administration. The resident did not receive the tube feeding supplement as outlined in the resident's plan of care. [s. 6. (7)]
