The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 6 & 7, 2016

The following critical incident inspections were completed:

CIS #2859-000076-16 - related to the prevention of abuse and neglect

CIS #2887-000059-16 - related to the prevention of abuse and neglect

Upon admission to an identified Long Term Care Home, a resident indicated they had been the victim of an alleged incident of abuse. The home contacted Hawthorn Woods Care Community and the Ministry of Health and Long Term Care to advise of the allegations.

During the course of the inspection, the inspector(s) spoke with two (2) Administrators, Director of Care (DOC), Director of Nursing and Personal Care, two (2) Assistant Directors of Care (ADOC's), Personal Support Workers (PSW's), Registered Nurse (RN), and the resident; interviews were conducted at two identified Long Term Care Homes. The inspector also toured the facility, observed the provision of care, and reviewed the home's policies and procedures.
