The following intakes were completed in this Follow up Inspection:

Log #027056-18- Follow up to Compliance Order #001 from RQI Inspection 2018_580568_0011/017267-18 related to O. Reg 79/10, s. 54(b), Responsive Behaviours; altercations and other interactions with residents-identifying and implementing interventions.

Log #030660-18- related to a Critical Incident Report (CIS) 2887-000045-18 submission for alleged resident to resident abuse.

The inspector toured the home and observed resident care, services and activities. Clinical records and plans of care for identified residents were reviewed. Also, relevant documents were reviewed including but not limited to the home's post-compliance order documentation, training and procedures as related to the inspection.

During the course of the inspection, the inspector(s) spoke with the Executive Director, Director of Care (DOC), Assistant Director of Care (ADOC), Environmental Services Manager, a Physiotherapy Assistant, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), residents and their families.
