Findings:

1. An identified applicant's admission to the home was refused on August 4, 2010 due to the licensee having several other residents with "extreme challenging behaviours" and not being able to manage the resident's "moderate to severe cognitive impairment". The home failed to provide detailed explanation related to the supporting facts as it related to both the home and to the applicant. The resident was subsequently admitted to the home in 2010.

However, the home failed to communicate this information in writing to the applicant and the Director. The resident was subsequently admitted to the home in 2010.
