# **AMENDED INSPECTION RESULTS**

### **Non-Compliance Remedied**

**Non-compliance** was found during this inspection and was **remedied** by the licensee prior to the conclusion of the inspection. The inspector was satisfied that the non-compliance met the intent of section 154 (2) and requires no further action.

The licensee failed to ensure that the readily available hand hygiene products were not expired.

#### **Rationale and Summary**

On July 19, 2023, the hand hygiene products in certain areas of the home were expired.

IPAC lead #101 acknowledged that hand sanitizers were expired and said they were removed immediately.
