- iv. have his or her personal health information within the meaning of the Personal Health Information Protection Act, 2004 kept confidential in accordance with that Act, and to have access to his or her records of personal health information, including his or her plan of care, in accordance with that Act.
- 12. Every resident has the right to receive care and assistance towards independence based on a restorative care philosophy to maximize independence to the greatest extent possible.
- 13. Every resident has the right not to be restrained, except in the limited circumstances provided for under this Act and subject to the requirements provided for under this Act.
- 14. Every resident has the right to communicate in confidence, receive visitors of his or her choice and consult in private with any person without interference.
- 15. Every resident who is dying or who is very ill has the right to have family and friends present 24 hours per day.
- 16. Every resident has the right to designate a person to receive information concerning any transfer or any hospitalization of the resident and to have that person receive that information immediately.
- 17. Every resident has the right to raise concerns or recommend changes in policies and services on behalf of himself or herself or others to the following persons and organizations without interference and without fear of coercion, discrimination or reprisal, whether directed at the resident or anyone else,

Findings/Faits saillants:

The licensee did not ensure that every resident's right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's

An identified resident was awoken prior to 0700hrs in 2012 by a male and female who entered her room. The individuals did not identify themselves and uncovered the resident. The resident identified that these two people did not explain why they were in the room, the female then left the room and the male touched the resident in a way that made her uncomfortable. The resident reported her concerns to staff who conducted an internal investigation. The female who entered the room was a registered staff person employed by the home and the male was a diagnostic technician who was performing a procedure at the time of the event.

Findings/Faits saillants:

1. The licensee did not ensure that copies of inspection reports from the past two years for the long term care home were posted in a conspicuous and easily accessible location with respect to the following:[79(3)(k) During a tour of the home on March 16, 2012 the location of the inspection reports the home is required to post could not be found. When staff pointed out the location and it was noted that the home maintains the inspection reports in a green binder that was hanging from a hook on the bottom of a bulletin board below the level a chair back that was placed in front of the bulletin board. The Director of Administration indicated that the inspection reports would be moved to a conspicuous, easily accessible location.

WN #3: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 76. Training Specifically failed to comply with the following subsections:

s. 76. (4) Every licensee shall ensure that the persons who have received training under subsection (2) receive retraining in the areas mentioned in that subsection at times or at intervals provided for in the regulations. 2007, c. 8, s. 76. (4).

Findings/Faits saillants:

- 1. The licensee did not ensure that all staff received retraining on The Residents' Bill of Rights accordance with LTCHA, 2007, S.O. 2007, c. 8 s. 76(2) and O. Reg. 79/10 s. 219 with respect to the following:
- The home provided documents indicating that a training session on The Residents' Bill of Rights was held on January 10, 2011 with 46 of approximately 160 staff in attendance.
- Staff responsible for coordinating education and orientation in the home confirmed that a system to track employee attendance at training programs was not implemented in 2011 and that up to March 19, 2012 no further training with respect to The Resident's Bill of Rights was held to ensure that all staff received this training.

If the Licensee is not served with written notice of the Director's decision within 28 days of receipt of the Licensee's request for review, this(these) Order(s) is(are) deemed to be confirmed by the Director and the Licensee is deemed to have been served with a copy of that decision on the expiry of the 28 day period.

The Licensee has the right to appeal the Director's decision on a request for review of an Inspector's Order(s) to the Health Services Appeal and Review Board (HSARB) in accordance with section 164 of the *Long-Term Care Homes Act, 2007*. The HSARB is an independent group of members not connected with the Ministry. They are appointed by legislation to review matters concerning health care services.
